THE DIRECT CONNECTION BETWEEN COVID "VACCINES" AND ENDANGERED MACAQUE MONKEYS

"The damage to humans caused by vaccines has been written about by medical experts, researchers, anti-vivisectionists, and people from every walk of life ever since Edward Jenner invented the disastrous smallpox vaccine in 1796. Leading the charge to educate the public about the toxic jabs was Eleanor McBean with her groundbreaking book *Vaccinations Condemned*, Hannah Allen with *Don't Get Stuck*, Sheri Tenpenny with *Say No to Vaccines: A Resource Guide for All Ages*, and PRISM'S own vaccine researcher and expert Sue Marston with *The Vaccination Connection* https://bit.ly/3WDgzTd. The pharmaceutical industry has continuously and viciously attacked and maligned these anti-vaccine activists and attempted in every way to destroy their reputations and credibility, which is impossible to accomplish since these writers and activists have the facts on their side.

Before the Covid scam, we at <u>PRISM</u> felt we were making steady progress in educating the public regarding vaccines. Many parents who talked to us at our information booths at veg fests and animal rights and health conferences were very knowledgeable about every aspect of vaccines and let us know they were aware that Congress passed a bill in 1986 that gave the vaccine industry a free pass to injure and kill multitudes of people without the possibly of getting sued. And that the vaccine court that was set up at the same time had paid out over \$4.5 billion in damages to the vaccine injured, none of the money coming from vaccine companies. These parents assured us they would not be vaccinating their kids.

Unlike many animal welfare groups, we as antivivisectionists, also made it clear in our personal interactions with the public and our publications, that vaccines are an integral part of the vivisection industry. Millions of animals have been tortured and slaughtered for the sake of the multibillion-dollar vaccine industry as both test subjects and ingredients in pharma's toxic witches' brew of animal pus and toxic chemicals. Up until three years ago, we felt that just like in 1986, when the vaccine manufacturers, in desperation, went to Congress to save their industry, the public was beginning to catch on to the fact that vaccines do not protect and instead, only cause damage. The vaccine religion was losing followers. Unfortunately, the scamdemic changed all of that.

Covid Vaccine Testing

We were shocked and horrified when we witnessed an overwhelming number of vegans and animal activists buying into the Covid scam and were eager to wear masks, social distance, and have toxic chemicals and spike proteins injected into their bodies to protect them from a nonexistent virus that had never been isolated. Vegans and animal activists, knowing that all vaccines are first created in the blood serum taken from the tortured bodies of cow fetuses, no longer cared about their morals and principles that had caused them to stop eating animals. As fearmongered as the rest of the public, they rolled up their sleeves and got the jab. Many Covid vaccine makers list a variety of animal tissues used in the design, manufacture, and production of their vaccines and assert they do their best to cleanse the vaccines of animal ingredients but cannot guarantee they are animal free and, as we know, any guarantee by vaccine companies is patently worthless. This month, a report, *How a Covid Vaccine Enriched Monkey Poachers and Endangered Macaques*, published by investigative reporters at NBC News, makes it clear how the public belief in vaccines has caused catastrophic damage to monkeys here and abroad. Every single person who says they care about animals but have pledged their loyalty to Fauci, pharma, the NIH, and the vaccine

religion are a part of the untold suffering inflicted on millions of monkeys bred and imported by the pharmaceutical industry to be brutalized in the name of vaccines and fraudulent bio-medical "research."

Not only are monkeys being bred for the vaccine/vivisection industry in the U.S. and other countries around the world, but thousands of monkeys are also being captured in the wild, crated, and shipped to vivisection labs in this country, many of them dying of shock, fear, and brutal conditions before they arrive. When the phony pandemic ratcheted up a call for vaccines and vaccine makers were salivating to make money off a fearmongered public, the demand for monkeys soared. A single, long-tailed macaque could cost up to \$40,000 dollars, up from \$3,000 just two years earlier, green monkeys and macaques being the preferred primate for gruesome experiments and as vaccine/drug test subjects. The Eunice Shriver Baby Monkey Labs alone, have tortured and killed an untold number of macaques in their vivariums for over 50 years.

Green monkeys carry the SV40 virus naturally and harmlessly in their bodies but when their organs are ground up and used in vaccines, the SV40 virus causes cancer in humans. In the face of overwhelming evidence to the contrary, for four decades the U.S. government insisted that there was no connection between cancer and the SV40 virus. Finally, in October of 2002, *The National Academy of Science Institute Immunization Safety Committee* published a report that admitted the SV40 simian virus is in both the Salk and Sabin vaccines and causes cancer in humans. Did that stop vaccine manufacturers from adding the SV40 virus into their vaccines via monkey tissue? Absolutely not. Why should the vaccine makers stop putting this virus into their vaccines? After all, if you get cancer from the SV40 virus, vaccine makers are above the law and can't be sued.

According to the NBC news article, after China banned the sale of wildlife at the start of the pandemic in March 2020, the floodgates of monkey breeding, poaching, and shipping them to the U.S. opened with a vengeance. "In 2019 Cambodia, (which has many macaque breeding farms that operate with little or no oversite) supplied 8,571 of the 33,818 monkeys imported into the U.S. or 25%. In 2021, the number of monkeys from Cambodia more than doubled to 18,870, making up nearly 60% of the 31,844 research monkeys brought to America." Which calls into question whether Cambodia's breeding farms are even capable of breeding that many monkeys and how many are actually poached in the wild.

CITES, the Convention on International Trade in Endangered Species of Wild Fauna and Flora, a 1975 treaty to protect the survival of certain plants and animals, found that Cambodians were trapping long-tailed macaques without permits and transferring them to breeding farms. Cambodians would also sell them to breeders in China and Vietnam who would falsely label them as originating in their own countries.

U.S. Fish and Wildlife agents claim they have been trying to investigate this industry for years but have been prevented from doing so by unnamed entities. Agents say that government officials in other countries are so corrupt it is impossible to know who to trust. "We'd be dealing with unknown players in foreign governments, many of whom are very corrupt. We had no way of knowing who had been paid off by illegal actors to help facilitate getting these animals out of the country of origin and into the U.S."

Nevertheless, in November of 2022, the U.S. Department of Justice charged 6 employees of the Vanny Bio Research breeding facilities in Cambodia and two Cambodian government officials with illegally exporting wild-caught monkeys to the U.S. If the charges stick and more people are arrested and prosecuted, maybe macaques will not remain in danger of being poached out of existence. In 2022, the *International Union for Conservation of Nature* changed the status of long-tailed macaques from "vulnerable" to "endangered." The driving force behind the endangerment of these monkeys? – the vaccine/vivisection industry, of course.

Considering the corrupt actions of Fauci and pharma in setting up illegal labs in Wuhan, it would not surprise us to find out that some these "illegal actors" in Southeast Asia mentioned by the investigating agents, are part of the powerful pharmaceutical industry whose vivisectors are always desperate to obtain more monkeys for their vaccine/vivisection labs.

Because of China's ban on exporting wild animals, vivisectors in this country want to expand their monkey breeding farms. Deborah fuller, the associate director of research at the *Washington National Primate Research Center* that breeds and tortures baby monkeys and their mothers, claims that the role monkeys played in developing and making Covid vaccines underscores how vital they are in drug research. Her statement is at the center of everything that we have been talking about for years - many of the people and groups who are opposed to vivisection and that are working to shut down the *National Primate Research Centers* believe in Covid and the vaccines. We are astonished that they cannot see the disconnect between working to shut down monkey breeding facilities and believing in the vaccines in which these monkeys are ingredients and for which they are test subjects. It's time to make the connection.

If we look at the CDC vaccine reporting site, VAERS, that records only one percent of the damage done by the Covid vaccines, then add three zeros to their number, we can see that as of December 9,

2022 many millions of people have been damaged and killed by the vaccines. Infants, children, and adults are dying of blood clots, heart attacks, anaphylactic shock, and more. Babies are being killed in the womb because pregnant women are choosing to get the toxic vaccine.
